### Course Description

This course will survey various approaches, that is, theories and 'models', applied in studies of the Chicano Latino experience. Discussion will focus US imperialism and on matters of ethnicity, racism and class as they have been applied to explaining history of the Chicano Latino community. The course will focus on the late 19<sup>th</sup> century to the present with particular attention to US-Mexico economic relations. In the opinion of the instructor, the late 19<sup>th</sup> century and early 20<sup>th</sup> centuries provided the beginning point for Chicano history. Consequently, we shall examine the historical relations between Mexico and the US over the course of the 20<sup>th</sup> century as a means for explaining, among other things, a century of Mexican migration to the United States and settlement as barrios and colonias across the US.

All readings will either be handed out in class or emailed as attachments. Consequently, there are no required books to purchase.
