Cultural and Historical Precedents for Latinos and Medical Care

Course Description

This course introduces the student to the history, culture, and social relations of Latinos/as in the United States. Historical eras surveyed in the class include Pre-Colombian life, the colonial period, and contemporary Latin American societies. Other issues examined include contemporary migration patterns, Latino diversity, labor market participation, gender relations, identity and race/ethnicity, family dynamics and social structure, and social incorporation, especially of the children of immigrants. The Latino/a experience will be placed within a framework that emphasizes globalization, transnational social spaces, and transculturation to understand the social and cultural implications of political and economic changes. In addition, the class will examine alternative healers and non-biomedical illnesses common to Latin Americans and Latinos. The course ends with an examination of biomedicine as a cultural system.

Requirements

<u>Readings</u>: Required readings for the class will include a combination of books, articles and book chapters. Arrangements will be made to have books and other readings available.

<u>Attendance</u>: Bi-Weekly over two quarters. Attendance is required. The format is a graduate seminar that requires active participation and discussion.

<u>Class Activities</u>: Students will come prepared to discuss readings and incorporate learning into their medical training and patient-based experiences. Students will generate learning questions from each session and then come prepared to present them at the next session, tying in their clinical experiences.

<u>Personal Narratives and Life Histories</u>: Students will present a personal narrative or brief life history based on an interview conducted with an adult (age 21 or

over) with whom the student met through clinical experience. This paper will be a maximum of 10 pages.

<u>Grading:</u> Grades will be based on a combination of class participation and the illness narrative writing assignment.

<u>Evaluation</u>: Students will be asked to evaluate the content and contribution of the class to their role as physicians in the Latino community based on their clinical experiences. Future course content and activities will integrate student evaluations.
