A two-quarter colloquium on the history and cultural background of contemporary Americans of Latin American descent. Emphasis will fall upon Americans of Mexican descent and geographically the U.S. Southwest and include the study of Puerto Ricans, Cubans, and "others." Goal of the course is to introduce the students to some of the major works, in history, social science and the arts, that are essential for understanding this aspect of the U.S. socio-historical development.
